- My mitigation project will expand my defensible space and improve firefighter safety. These should include removing ladder fuels, and increasing tree crown separation to reduce crown fire potential. Other considerations:

Describe briefly, including legal description (Lot/Block/Filing):

- My mitigation project is for Firewise landscaping that will help reduce risk of ember ignitions (#1 cause of home losses!). **\*\*NEW Category\*\* Requires pre-approval by the Project Forester or LFPD Fire Marshal.** It meets one or more of the following criteria:
- ✓ Removal of combustible materials (mulches, landscape timbers, fences, etc.) typically within five feet of the structure.
  - ✓ Replacement with non-combustible materials that also meet the following criteria:

- Provide 5 inches of vertical clearance from the top of the non-combustible material to the lower edge of siding or structure.
- Provide positive drainage away from the structure.
- Addresses areas where embers may collect due to wind eddies. (Note- Think of where the leaves or snow accumulate around your house after a windy day. These same areas will accumulate embers during a wind driven wildfire.)
